

Spaceship Institute

Institute was established by [Keshe Foundation](#) in northern Italy near Desenzano del Garda in year 2014 for spreading its knowledge and technology to public and for their further development.

Knowledge seekers should know [plasma theory](#) and practically in a lab also [plasma technology](#) and should [share the gained experiences openly](#) with people in their language.

Teachings of Mr. Keshe was planned for at least two years. Yearly teaching fee was set to 20 000 €, quaterly 5 000 €.
